# **Privacy Policy**

Effective date: 28<sup>th</sup> July, 2019

This is the privacy policy (" **Privacy Policy** ") for information collected by Gold Star Adventures a boat charter company that offers tours and adventure trips to client exploring the Eleuthera and surrounding islands. This website is created by Gold Star Adventures L.L.C. and for <a href="https://www.goldstaradventures.org">https://www.goldstaradventures.org</a> (" **Site** "). The Site is operated by or on behalf of Gold Star Adventures .

Our Privacy Policy explains:

- What information we collect and why we collect it.
- How we use that information.
- The choices we offer, including how to access and update information.

It is Gold Star Adventure's policy to respect your privacy regarding any information we may collect while in the course of operating our website. "https://www.goldstaradventures.org"). We respect your privacy and are committed to protecting personally identifiable information you may provide us through the Website. We have adopted this privacy policy ("Privacy Policy") to explain what information may be collected on our Website, how we use this information, and under what circumstances we may disclose the information to third parties. This Privacy Policy applies only to information we collect through the Website and does not apply to our collection of information from other sources.

This Privacy Policy, together with the Terms and conditions posted on our Website, set forth the general rules and policies governing your use of our Website. Depending on your activities when visiting our Website, you may be required to agree to additional terms and conditions.

#### Information that we collect

We collect information to provide better services to all those with whom we deal.

We collect information in the following ways:

- Information you give us. We collect personally identifiable information, like names, email addresses, and contact information that is voluntarily submitted by our visitors. This information is only used to fulfill your specific request, and to sign you up for our service, unless you give us permission to use it in other manners. When you do, the information will only be used subject to your request only.
- Information we collect or receive in the course of finding a perfect match for you. We collect information in a variety of ways to facilitate our services. This can include direct entry via forms, download through other websites, tracking codes such as cookies that save or track information about app usage, and automatically sent information such as IP address and device IDs.
- Information we get from your use of our Site. We may collect information about the parts of the Site that you use and how you use it. This information includes:

# Device information

We may collect device-specific information (such as your hardware model, operating system version, unique device identifiers, and mobile network information including phone number).

# • Log information

When you use our Site, we may automatically collect and store certain information in server logs. This may include:

- details of how you used our Site
- Internet protocol address
- device event information, such as crashes, system activity, hardware settings, browser type, browser language, the date and time of your request and referral URL

• cookies that may uniquely identify your browser

#### Location information

We may collect and process information about your actual location and use various technologies to determine location, including IP address.

# o Local storage

We may collect and store information (including personal information) locally on your device using mechanisms such as browser web storage and application data caches.

# Cookies and similar technologies

We may use various technologies to collect and store information when you visit our Site, and this may include using cookies or similar technologies to identify your browser or device. You may set your browser to block all cookies, including cookies associated with this Site or to indicate when a cookie is being set by us.

#### How we use information that we collect

We use the information we collect from our Site to provide, maintain, protect and improve it and to protect our users. We may use information collected from cookies and other technologies to improve your user experience and the overall quality of our Site.

We may also use the information you provide us with, to contact you from time to time so as to provide you with important information, required notices and marketing promotions. You may opt out or unsubscribe from these notices at any time.

When you contact us, we may also keep a record of your communication to help solve any issues you might be facing. We may use your email address to inform you about our business, such as letting you know about upcoming events or changes to our site.

#### Our legal basis for processing your personal information

We rely on the following provisions, under the Statute of the Law of Bahamas Cap 324A data protection law that is construed to protect the privacy and collection of personal data

- Where we have obtained your consent, for example to action a request from you or respond to your specific query. You can withdraw your consent at any time, but we may still need to retain a record of your correspondence with us.
- Where it is necessary for the purposes of our legitimate interests to manage our existing

investments and explore new investment opportunities, including conducting legal and commercial due diligence.

• Where it is necessary to comply with a legal obligation, for example under anti-money laundering or anti-bribery legislation or court orders and subpoenas.

#### Website Visitors

Like most website operators, Gold Star Adventures collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Gold Star Adventures's purpose in collecting non-personally identifying information is to better understand how Gold Star Adventures's visitors use its website. From time to time, Gold Star Adventures may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Gold Star Adventures also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on http://www.goldstaradventures.org blog posts. Gold Star Adventures only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below.

#### Children and minors.

We do not use the Application to knowingly solicit data from or market to children and teens under the age of 18 as dictated by the laws of Bahamas. Our applications are rated 18+ and may be limited to geographical location. If a parent or guardian becomes aware that his or her child has provided us with information without their consent, he or she should contact us at goldstaradventures@gmail.com. We will delete such information from our files within a reasonable time.

#### Security

The security of your Personal Information is important to us, but remember that no method of transmission over the Internet, or method of electronic storage is 100% secure. While we strive to

use commercially acceptable means to protect your Personal Information, we cannot guarantee its absolute security.

#### **Advertisements**

Ads appearing on our website may be delivered to users by advertising partners, who may set cookies. These cookies allow the ad server to recognize your computer each time they send you an online advertisement to compile information about you or others who use your computer. This information allows ad networks to, among other things, deliver targeted advertisements that they believe will be of most interest to you. # Www.Gold Star Adventures .org uses Google AdWords for remarketing

Www.Gold Star Adventures .org uses the remarketing services to advertise on third party websites (including Google) to previous visitors to our site. Where personal information is transferred outside the Bahamas, we will take all steps reasonably necessary to ensure that it is subject to appropriate safeguards and that it is treated securely and in accordance with this Privacy Policy.

# Accountability for onward transfers

We are responsible and remain liable for the processing of personal information we receive, Under the Privacy Shield Frameworks, including if we subsequently transfer to a third party acting as an agent on its behalf. We comply with the Privacy Shield Principles for all onward transfers of personal information from the Bahamas and other nations. With respect to personal information received or transferred pursuant to the Privacy Shield Frameworks, we are subject to the regulatory enforcement powers of Statute of the Law of Bahamas Cap 324A. In certain situations, we may be required to disclose personal information in response to lawful requests by public authorities, including to meet national security or law enforcement requirements.

# Resolution of Privacy Shield queries and complaint mechanism

In compliance with the Privacy Shield Principles, we commit to resolve complaints about any Collection or use of your personal information. We commit to cooperate with the Statute of the Law of Bahamas Cap 324A in ensuring Protection of Information.

#### Accessing and updating your personal information

If you are resident in the Bahamas your personal information is processed in the context of Bahamas privacy laws and, you have certain legal rights in respect of the personal information about you held by us. This includes the right to obtain a copy of this information on request, and the right to correct, amend or delete such personal information or object to it being used for certain

purposes (including marketing). We may ask you to verify your identity before we can act on your request. We will comply with any requests to exercise your rights in accordance with applicable law, and so there may be circumstances where we are entitled to refuse your request. For example, where permitted to by law, we may reject requests that are unreasonably repetitive, require disproportionate technical effort (for example, developing a new system or fundamentally changing an existing practice), risk the privacy of others, or would be extremely impractical (for instance, requests concerning information residing on backup systems).

Where we can provide information access and correction, we will do so free of charge, except where it would require a disproportionate effort (where we are permitted to charge a fee under applicable law). We aim to maintain any information we hold and our Site in a manner that protects information from accidental or malicious destruction.

#### Information that we share

# • With your consent

## • For external processing

We provide personal information to our affiliates or other trusted businesses or persons to process it for us (or for similar reasons), based on our instructions and in compliance with our Privacy Policy and any other appropriate confidentiality and security measures.

# • With our legal and professional advisors

We share information with our legal and other professional advisors, for example if they are advising us on an investment transaction or where otherwise necessary to obtain their advice.

#### • For legal reasons

We may share personal information with companies, organizations or individual's outside Gold Star Adventures if we have a belief in good faith that access, use, preservation or disclosure of the information is reasonably necessary to:

- meet any applicable law, regulation, legal process or enforceable governmental request.
- enforce applicable terms of service, including investigation of potential violations.
- detect, prevent or otherwise address fraud, security or technical issues.
- protect against harm to the rights, property or safety of Gold Star Adventures, our users or the public, as required or permitted by law.

If Gold Star Adventures is involved in a merger, acquisition or asset sale of Gold Star Adventures , we will use reasonable endeavors to ensure the personal information we process continues to be subject to the same protections set out in this Privacy Policy.

# Information security

We work hard to protect our Site and any information that we hold from unauthorized access or unauthorized alteration, disclosure or destruction. In particular:

- We review our information collection, storage and processing practices, including physical security measures, to guard against unauthorized access to systems.
- We restrict access to personal information to Gold Star Adventures employees, contractors, service providers and agents who need to know that information in order to process it for us and who are subject to strict contractual confidentiality obligations. They may be disciplined or their contract terminated if they fail to meet these obligations.

# When this Privacy Policy applies

Our Privacy Policy applies to all of the services offered and businesses operated by Gold Star Adventures, but excludes services and businesses that have separate privacy policies that do not incorporate this Privacy Policy.

Our Privacy Policy does not apply to services offered or businesses operated by other companies or individuals. Our Privacy Policy does not cover the information practices of other Companies and organizations that advertise our services and that may use cookies, pixel tags and other technologies.
